App. 569, 675 A.2d 715 (1995) cert. denied, 343 Md. 564, 683 A.2d 177 (1996), wherein he prevailed before the appellate courts in a reported opinion, to change the way mechanics liens are pled in Maryland. Mr. Etelson also made law in another reported opinion before the Appellate court, *Messina v. Krakower*, wherein the Court sided with Mr. Etelson in upholding the absolute privilege in confidentiality matters.

Mr. Etelson was appointed by the governor of the State of Maryland to serve on a commission to rewrite the lease litigation law of the State of Maryland. In 1997, he was appointed by the governor of the State of Maryland to serve as a trustee of the Chesapeake Bay Trust, a multi-million dollar state-created trust dedicated to supplying grants for the rehabilitation of the Chesapeake Bay.
