Results

- Won a four-day bench trial on behalf of a national real estate developer in Arlington, VA who was sued for Slander of Title. Secured a directed verdict at close of plaintiff's case. Won our client's counterclaim and secured a high six-figure judgment for damages and attorneys' fees.
- Persuaded a Fairfax, VA Court to adopt Maryland "Vendee Lien" law to recover millions in developer bonds posted as a contract deposit.
