## Results

### Complex Commercial Litigation and Dispute Resolution Matters

 Patent infringement defense counsel for national industrial refrigeration company: W.D.
Va. and the Federal Circuit. Following extensive due diligence and analysis of claim construction and infringement contentions, advised client to reject plaintiff's early settlement demand. Prevailed following evidentiary *Markman* hearing and obtained judgment of noninfringement that plaintiff appealed. Advised client to again reject unreasonable settlement demand. Following oral argument, the Federal Circuit affirmed in January of 2023. The cost of obtaining a judgment of noninfringement was less than 30% of the lowest settlement demand.

- Lead defense counsel in nationwide class action representing national retailer and private label manufacturer: N.D. Ill. and the Seventh Circuit. Defense counsel for nationwide consumer class action. Obtained order from the Judicial Panel on Multidistrict Litigation consolidating multiple cases filed in various jurisdictions. Following settlement conference in which plaintiffs' demands were unreasonable, coordinated with multiple cocounsel firms and obtained dismissal of all claims. Plaintiffs appealed and, following briefing and oral argument, the Seventh Circuit affirmed dismissal. Negotiated nominal settlement with plaintiffs to lessen likelihood of future litigation and to meet client objectives.
- Lead plaintiff's counsel for international corporation in tort and trade secret action against former owner: Circuit Court for Maryland, Maryland Appellate Court, and Bankr. M.D.N.C. Obtained a multimillion-dollar judgment following trial in a Maryland state trial court against disloyal former owner who refused to settle. Maryland Appellate Court affirmed and, in a published opinion, adopted argument for new standard for asserting personal jurisdiction in Maryland. Defendant filed bankruptcy in North Carolina. Following extensive discovery and motions practice, obtained a judgment of nondischargeability.

- Lead defense counsel for technology startup in noncompetition, copyright infringement, and contract action: E.D. La. Defended technology company against aggressive claims by existing competitor. Advised client to reject competitor's initial and multiple pretrial settlement demands of more than 50-million dollars. Following the first week of a multi-week trial, plaintiff settled for less than 5% of its lowest pretrial demand.
- Lead defense counsel in federal class action by current and former employees and contractors alleging FLSA and various related claims: D. Md. Following extensive due diligence and analysis, advised client regarding likelihood of liability and range of potential damages. Negotiated early classwide settlement that the Court approved that was about 25% of client's potential liability, to be paid over significant time. Result was that client avoided bankruptcy.
- Lead trademark cancelation counsel before the U.S. Patent & Trademark Office.
  Representing Washington, D.C. based retailer seeking to cancel competitor's registered marks on several grounds.
